#### 146.2 PLANNING

Application

MJD/08/07533/FUL – land rear of 10 Beechwood Road – erection of 1 x 2 bed bungalow and detached garage with alterations to existing access, demolition of existing garage and erection of new detached garage with creation of parking space for no 10 Beechwood Road (amended scheme to pp 08/05474/FUL) construction of single storey front extension and insertion of front bay window in connection with a garage conversion – no objection MJD/08/07580/FUL – 355 West Wycombe Road – const of part two storey, part single storey rear extension and alterations and conversion of existing dwelling into 4 x 1 bed flats with new shared access with no 353, provision of 4 x car parking spaces, individual balcony and communal amenity and bin and cycle stores – no objection

GMG/08/07629/FUL – 12 Bradenham Road – construction of single storey front extension – no objection as long as it comes within the 50% rule. PECS/08/07652/CTREE - The Car Park, Church Lane –crown lift to 5m, clean out crown of dead/dying weak or crossing branches to 1 sycamore tree – no objection

ELH/08/07377/FUL – Kingscote, Park Farm Road (amended) – construction of single storey front extension and insertion of front bay window in connection with a garage conversion – although the applicant has made a modification to the plan the Parish Council still feels the area for parking is inadequate for a 5 bedroomed property Decisions -None received

#### 146.3 Finance

<u>To recommend an increase in the Standing Order for the Old Folks</u> <u>Christmas Party</u>

The current s/o has been at £50 for at least 10 years. It was resolved to increase this to £100 per annum.

To discuss Community Donations

It was resolved to donate £1000 to West Wycombe Community Library and £2000 for West Wycombe Community Association.

To consider the proposed NALC/SLCC interim pay rise backdated to April 08. The pay rise will mean an extra £13.36 per month backdated to1st April 2008. Mileage is 58.7p per mile. It was resolved to pay the interim pay rise. To set the Precept for 2009/2010

Cllr Callaghan proposed a Precept of £30,000, this was seconded by Cllr Downes and unanimously accepted. It was resolved to set the Precept at £30,000.

#### 146.4 Highways issues

Mr Phillips reported on the highways situation relating to the proposed maintenance work to the properties in the High Street, BCC wanted 17 parking spaces blocked off which would have affected the traders prior to Christmas. They have re-phased the work and this part of the village will now take place after Christmas for 4-6 weeks.

Clerk has been in contact with BCC re the new bollards at the top of Copperfields but at the moment BCC say they are fine and just make people sit and observe more before they exit the road. Clerk will forward photo illustrating the problem.

Light outside no 12 Chorley Road not functioning.
