CONFIRMATION AND SIGNING OF MINUTES OF THE OCTOBER PARISH COUNCIL MEETING These were agreed by those Councillors present and signed by the Chairman.

REPORT ON PROGRESS ON ITEMS FROM PREVIOUS MINUTES

- 1.Clerk has shown the new Local Area Technician our parish and listed works required however when viewing the Community Gang list not all this work is listed and we have seen no evidence of the Community Gang but as all our Transport for Bucks contacts are on annual leave we cannot raise our concerns. Cllr Downes will raise the issue of staffing.
- 2. Hedges on the allotments and along Cookshall Lane have been cut.
- 3. The playing field has been cut but the contractor has been asked to cut again to get it lower as well as tidy up all the perimeter growth
- 4. Councillors and the Clerk had a site meeting at the Pedestal Playing Field with 4C a charity organisation who may be interested in helping with the pavilion as long as we have a remit from the community and a business plan.
- 5. Allotment rent two are still outstanding.
- 6.Cllr Seymour presented a price of £21 plus VAT for sheep protection per tree which comprises a 6ft post with 6ft high netting.
- 7. Cllr Mrs Smith along with residents and shopkeepers have met with the National Trust to discuss the current programme of works to ensure that as much parking as possible will be available for everyone. The first stage should be completed by the first week of December.
- 8. The Clerk issued the final account for the Fete. Cllr Downes continued to question the Parish Council contribution for the event.

189.5 To consider a statement issued by NALC about Precepts

NALC have issued a statement stating that Parishes should not consider setting the Precept until after the Chancellor's Autumn Budget Statement in early December. We believe this is in connection with the proposed 10% reduction in funding to District and County Council by the government and a change in Council Tax benefit and Council Tax base.

189.6 <u>To discuss Remembrance Su</u>nday

The poppy wreath has been purchased with a S137 donation of £50 from the Royal British Legion. A Service of Remembrance will take place at the War Memorial in St Lawrence Churchyard commencing at 10.45 on Sunday 11th November.

189.7 To discuss the Christmas tree and lights

The tree will be erected on Monday 26th November. The lights have also been checked. The lights in the tree near the park gates have been checked and all are functioning. The Clerk will put up no parking notices for the Village Hall.

189.8 <u>To consider banning all dogs from the Pedestal Playing Field and to place an order for the creation of a bund at a cost not in excess of £700</u>

Cllr Seymour and the Clerk have briefed Hawes for the bund and a price of £375 plus VAT has been given. We will need to turf it and this will cost approximately another £50. We need volunteers to help lay the turf. We do not want to leave it as a mud bank for any longer than we can help. We may need to hire a grab loader as an extra to remove the final material left on the front boundary hence the price of £700. It was resolved to proceed with placing the order for the work.

During recent site visits to the Pedestal Playing Field a large amount of dog faeces were seen, nearly all produced by large dogs. This is neither good for the users of the area or the grass cutting contractors. It was resolved that we would start by putting up a sign reminding people to clear up otherwise dogs will be banned.

189.9 <u>Highways issues which need reporting or acting upon and to receive a BCC report on 20mph speed limits and the creation of Traffic Regulation Orders.</u>

The Clerk has been advised by Transport for Bucks that we can bid for the Church Lane Waiting Restriction project through the LAF for the year 2013/2014. It was suggested that we match fund this project in order to have any chance of success.

The Clerk issued information sheets on TRO's, 20mph speed limits, potholes and the role of Local Area Technicians.

Items either reported or to be reported: Kerbstone near Pedestal; kerbstone by The Sweet Shop; all the non functioning lights have been reported;

To discuss the budget for 2013/2014 and the projected year end for 2012/2013

The Clerk, prior to the meeting, issued a projected year end spreadsheet, suggested budget and detailed information on finance for the coming year.

Price from Mr Gomme for rolling (1), grass cutting (11), hedge work, weed killing the Pedestal Playing Field - £2185 per annum (£182 per month) currently pay £176 for a less comprehensive job.

Price for two cuts per year on the two areas of verge from the Pedestal Memorial to the Village and the Park gates at Kittys Lodge to the village - £80.

Crown lifting and tidying four trees in the Pedestal Playing Field - £200.

We may need to replace the football goals - prices vary from £600 - £1000

Burial Ground top field needs a management plan -

Traffic Regulation Order - £5500 – contribute 50% of this cost.

Reserve for replacement lighting due to age and new EU regulations which come into force in 2017 and for generally unexpected occurrences.

Sun shelter for Pedestal Playing Field.

Councillors will consider the document.

189.11 To approve the accounts for November 2012 and signing of cheques – appendix 2

It was agreed that Cllr Timberlake will be another cheque signatory.
