187.6 To discuss the Pavilion on The Pedestal Playing Field

Clerk contacted one local roofing company but to date they have not provided an estimate. It was agreed that at the present time we would not spend any money on the building as it is not included in our lease.

187.7 <u>To discuss whether to increase allotment rents</u> It was agreed not to increase the rents.

187.8 To approve the accounts for August & September 2012 and signing of cheques – appendix 2 Mazars have completed their audit. Nothing raised in connection with the audit only a note that the RFO had transposed two figures in the bank reconciliation and we should not increase the value of our assets even if the insurance company does. See financial statement at end of Minutes. It was resolved to accept the accounts.

### 187.9 Members questions

Six sets of Roman remains, found in Church Lane in 2009, were interred in West Wycombe Burial Ground during August.

Cllr Timberlake will circulate all the members of the Parish Plan committee to reconvene. The idea for a permanent commemorative feature for a seating bund in the Pedestal Playing and a structure to provide shade will be costed for the next meeting.
