REPORT ON PROGRESS ON ITEMS FROM PREVIOUS MINUTES AND CLERK'S REPORT

- 1. The large branch in the Pedestal Field has been removed and a roll and first cut have been undertaken.
- 2. The advert in the Bucks Free Press for the HS2 'Petition' parliament has appeared .
- 3. Parish Plans have been printed off. Hard copies in library and electronic copies emailed to our County and District Councillors, the Emergency Team, Planning at WDC and the new Local Plan team. It is on the website and it has been announced in Contact.
- 4. The road planings have been delivered and spread at the allotments and the Pedestal Playing Field. A second unexpected delivery was made one load has been moved to the allotments and it is planned to spread the remainder on 14th April.
- 5. Cllrs Mrs Teesdale and Mr McEnnis have each donated £490.00 from their Ward budget for the allotment water project this has been paid into the bank and thank you letters sent
- 6. BCC has paid £200 towards the bus timetable project (this money was paid direct to the deposit account) hard copies have been printed off and put in the library and they are all on our website. The May issue of Contact will advise residents of their availability. The project cost £149. The balance of £61 will be used for regular update printing.

- 8. All the 'Dogs on Lead' signs are up and it was announced in Contact.

205.3 High Speed Rail (London-West Midlands) Bill

The following notice appeared in the Bucks Free Press on 28th March

IN PURSUANCE of section 239 of the Local Government Act 1972, NOTICE IS HEREBY GIVEN that a meeting of West Wycombe Parish Council will be held at The Church Room, High Street, West Wycombe on Thursday the 10th day of April 2014 at 8 o'clock in the evening to take into consideration and determine upon the expediency of opposing in Parliament the High Speed Rail (London-West Midlands) Bill deposited in the session 2013-14 and also for the purpose (if deemed expedient to oppose such Bill) of passing such resolutions as may be necessary or expedient in connection with the opposition to such Bill.

It was resolved that in the judgement of the West Wycombe Parish Council it is expedient for the Council to oppose the High Speed Rail (London-West Midlands) Bill introduced in the Session of Parliament 2013 – 2014.

205.4 To appoint a Role B Agent to present the HS2 petition to parliament

It was resolved that Mrs Sharon Linda Henson, Clerk and RFO to West Wycombe Parish Council take all necessary steps to carry the foregoing Resolution into effect and that confirmation be given that Mrs Sharon Henson be authorised to sign the Petition of the Council against the Bill.

205.5 To agree to approach HS2 to negotiate this parish's objections to the proposed construction route

It was resolved to present a letter to HS2 to try and negotiate our objections to the use of Junction 4 of the M40 and the route through our parish for the construction phase of HS2.

205.6 To report and discuss any highways issues

All the potholes have been reported and now the road is completely dry the road surface on one side has been repaired. The Clerk organised failed road surface signs to make drivers more careful when approaching the Pedestal roundabout. BCC did not repair the potholes along the High Street.

The pavements in the High Street have been resurfaced but not to a very good standard and the work on the shop side has spoilt the excellent pavement created by Southern Electric. Unfortunately they did not extend the resurfacing to the Pedestal roundabout sections. The Clerk asked WDC to sweep the pavements from the village to the Pedestal Roundabout – this has been completed but is going to take several sweeps.

County Cllr Hayday has asked if we want further pavement work undertaken and the Clerk has requested from Gerrard Court to the village and from the Pedestal to the village.

The 45 minute no waiting sign outside The Sweet Shop was replaced in mid March, was on the wall for a week and then vanished. We have reported it and will try to get it fixed with security screws. It is theft.

VAS sign on Oxford Road and 30mph signs not lit/working and light number 26 have all been reported.

Cutty Alley and the path to the toilets need clearing – the Clerk will organise this.

205.7 To sign the agreement between the Parish Council and Bucks County Council for the maintenance of 3 footpaths/bridleways in the parish.

The agreement between Bucks CC and West Wycombe Parish Council was signed and the Chiltern Society will be contacted regarding the work. Thames Water and Environmental Health at WDC have been contacted about sewage material on the footpath at Park Farm.

205.8 To approve the accounts for the year ending 31st March 2014

Prior to the meeting, the Clerk had issued end of year accounts and a trial balance to all Councillors. It was resolved to approve the accounts for the year ending 31st March 2014.
